#### **OVERVIEW:**

Establishes and implements cycle count plans according to ASV Guidelines. Reports and analyzes inventory inaccuracies and trends. Reconciles inaccuracies and researches to find the root cause of inventory discrepancies. Works with materials, engineering, manufacturing, purchasing, and finance to rectify issues with inventory counts and leads the implementation of improvement processes. Communicates metrics and performance.

  - Completing necessary adjustments/transactions to maintain accurate inventory records

  - Completing root cause analysis of inventory discrepancies and identifying improvement opportunities
  - o Identify & Lead inventory accuracy improvement projects
  - Troubleshoot issues and develop corrective actions
  - Define and implement processes relating to inventory control
  - Schedule and facilitate meetings with team and other departments
  - o Facilitate cross-department continuous improvements
  - o Participation on Inventory Management team
  - ECN participation and inventory role
  - Establish and maintain positive team member relations
  - Scheduling and leading meetings to update Production Control & Finance team on performance; Communicate with other group leaders and managers
  - Responsible for end-of-month reporting by balancing negative inventory balances to zero by transfers, inventory adjustment or Kanban.
